

**SELENA GOMEZ STRANDS TO MYSELF ENTER-TO-WIN SWEEPSTAKES  
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN, NOR WILL A PURCHASE IMPROVE ONE'S CHANCES OF WINNING**

1. SPONSOR: Interscope Records, 2220 Colorado Ave, Santa Monica, CA 90404, is solely responsible for all aspects of this sweepstakes ("Sweepstakes").
2. ENTRY: You may enter this Sweepstakes "Entry(ies)" during the period beginning at 12:01 A.M PST, February 17<sup>th</sup>, 2016, and ending at 11:59:59 P.M., March 23<sup>rd</sup>, 2016 ("Entry Period"). For purposes of these Official Rules ("Rules").

To enter, visit <http://smarturl.it/StrandsToMyself> choose the "SUBMIT" button after filling out all required fields. After doing so, you are officially entered into the pool of eligible entrants.

3. LIMITATIONS: All Entries must be received by 11:59:59 P.M., March 23<sup>rd</sup>, 2016. In event of a dispute regarding the identity of the person submitting an Entry, the Entry will be deemed to be submitted by the person in whose name the Address is registered.
