

## REPUBLIC RECORDS SOCIAL SWEEPSTAKES 011 OFFICIAL RULES

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.**

**A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

**DO NOT ENTER THIS SWEEPSTAKES IF YOU DO NOT RESIDE WITHIN THE 50 UNITED STATES INCLUDING THE DISTRICT OF COLUMBIA. VOID WHERE PROHIBITED BY LAW.**

**SPONSOR:** Republic Records, a division of UMG Recordings, Inc., (“Republic” or “Sponsor”), 1755 Broadway, New York, NY 10019, is solely responsible for all aspects of this sweepstakes.

**ENTRY:** The Republic Records Social Sweepstakes 011 sweepstakes (“Sweepstakes”) begins at 12:00:00 P.M. on May 23, 2020 and ends at 11:59:59 A.M. on May 30, 2020 (“Entry Period”). For purposes of these Official Rules (“Rules”), all times and days are Eastern Time (“ET”). You may enter the Sweepstakes by visiting <https://republic.re/sweeps> (“Website”) and following all onscreen instructions to enter your first and last name, email, zip code and click “Submit” (“Entry”). After clicking “Submit”, you are officially entered into the pool of eligible entries (“Entry”). Only (1) one Entry per person. At the end of the Sweepstakes period, potential winner will be chosen at random from all eligible Entries received during the Entry Period.

**LIMITATIONS:** In event of a dispute regarding the identity of the person submitting an Entry, the Entry will be deemed to be submitted by the person in whose name the email address is registered. Entries by any method other than set forth above in Section 2 are void. Any use of automated or programmed methods of effecting Entry is prohibited. Sweepstakes is open only to persons 13+ or older who are legal residents of, and physically located within, the fifty (50) United States including the District of Columbia (collectively, “Territory”) at time of entry. Void where prohibited by law. Employees of Sponsor and their parent, subsidiary, affiliated or successor companies; or the advertising, promotional or fulfillment agencies of any of them (individually and collectively, “Entities”); nor members of their households or immediate families are eligible to enter or win. Neither the Entities, nor any of their officers, directors, shareholders, employees, agents or representatives (individually and collectively, “Releasees”) are responsible for Entries from persons residing, or physically located, outside the Territory; Entries that are altered, delayed, deleted, destroyed, forged, fraudulent, improperly accessed, inaccurate, incomplete, interrupted, irregular in any way, late, lost, misdirected, multiple, non-delivered, stolen, tampered with, unauthorized, unintelligible or otherwise not in compliance with these Rules; or for lost, interrupted or unavailable satellite, network, server, internet service provider (“Internet Service Provider”), website (“Website”) or other connections; telephone or cell phone availability or accessibility; miscommunications; failed computer, satellite, telephone or cable transmissions, lines or technical failure; jumbled, corrupted, scrambled, delayed or misdirected transmissions; computer hardware or software malfunctions, failures, technical errors or difficulties; unauthorized human intervention; traffic congestion; undeliverable emails resulting from any form of active or passive email filtering; or other errors of any kind, whether due to electronic, mechanical or human error or other causes; even if caused by the negligence of any of the Releasees. Each of such potential Entries will be disqualified and any attempt by a person to use

multiple email or Service Provider accounts to register more than once may result in disqualification at Sponsor's sole discretion. Void where prohibited.

**PRIZE:** One (1) prize package ("Prize") will be awarded. Prize winner will receive one (1) Republic Records prize package consisting of various audio products, t-shirts and/or hoodies valued at \$150.00. Approximate retail value ("ARV") of Prize: \$150.00. ARV of all Prizes: \$150.00. All taxes, gratuities, incidentals, upgrades, service charges or other expenses not specified herein are not included and are the Prize winner's sole responsibility. Certain restrictions may apply. Limit: One prize per person or household. If actual value of any Prize is lower than the stated ARV when prize is procured and fulfilled, then the difference will not be awarded. **WINNER SELECTION & ODDS:** On or about May 30, 2020, in a random drawing, potential winner will be selected from all eligible Entries received during the Entry Period. Odds of winning depend on the total number of eligible Entries received during the Entry Period.

**WINNER NOTIFICATION:** An email Prize notification will be sent to the potential winner within twenty-four (24) hours after the random drawing is conducted. Winner must also be able to receive calls from an unlisted/blocked number (or have access to) an internet connection to receive emails from the Sponsor and/or its designated agent. The contact information provided at time of Entry will be used to notify a winner. The winner will be required to respond to the prize notification within twenty-four (24) hours of notification deployment in order to receive any required documents, including (if applicable) an Affidavit of Eligibility/Grant of Rights and Liability/Publicity Release ("Affidavit") which must be signed and returned to Sponsor or its designated agent within twenty-four (24) hours of notification deployment.
