**THE Keith Urban "The Fighter" CMT Awards Flyaway SWEEPSTAKES ("SWEEPSTAKES") BEGINS AT 12:00:00 A.M. CENTRAL TIME ("CT") ON 4/02/17 AND ENDS AT 11:59:59 P.M. CT ON 5/5/17 ("ENTRY PERIOD").**

**SPONSOR:** Universal Music Group Nashville, 401 Commerce Street, Suite 1100, Nashville, TN 37219 (referred to herein as the "Sponsor" or "UMGN").

**ELIGIBILITY:** Sweepstakes is open to legal residents of; and physically located within the contiguous United States and the District of Columbia age 21 or older at time of entry. The Sweepstakes and any website page(s) and advertisements relating thereto, are intended for viewing within the contiguous United States only. Employees of the Sponsor, their respective parent companies, affiliates, subsidiaries, agents, advertising and promotions agencies, crew members, and any other individual or company involved in the development or execution of the Sweepstakes ("Released Parties") and their immediate families (parents, siblings, children and their respective spouses) and same households of each, whether or not related are not eligible to enter or win. **PRIZE AND APPROXIMATE RETAIL VALUE ("ARV"):** One (1) Grand Prize will to be awarded to winner (and one (1) guest) to attend the CMT Awards ("Event") on 6/8/17 in Nashville, TN. Approximate Retail Value ("ARV") of prize: \$2,500.00. If actual value of any prize is lower than the stated ARV when prize is procured and fulfilled, the difference will not be awarded.
